- 8. All competitors must present current SOBHD registration card before receiving their number. Awards will be held and a \$5 fee will be charged for any dancer without a current SOBHD card.
- 9. Prizes: **Cash Prizes awarded in the 16 & Over Premier Classes and medals in all other classes. A special prize will be awarded for the Special Fling in Beginner and Novice.
- 10. \$15.00 late entry fee will apply for any entries postmarked after June 27, 2017.
- 11. There will be **NO** entry fee refunds.
